New Updates

COVID-19 serology testing and PCR testing principles.

Recovering from the acute part of dealing with the pandemic will require expanded testing to identify individuals actively infected by the SARS-CoV2 virus and those who have recovered from the infection. Serology testing is critical to identify the second group. Unfortunately, reports on the initial serology tests for antibodies indicate that those tests are not as accurate as needed at this time. The Testing Stewardship group, led by Drs. Marie Landry, Scott Sussman, and Peter Schulam, have created information regarding serology testing and have updated guidelines for the use of PCR testing to identify active infections.

YNHHS Pharmacist COVID 19 Monitoring and Standing Orders

YNHHS Pharmacy, in collaboration with inpatient and critical care teams, have developed a process to ensure that appropriate drug monitoring is performed for COVID-19 inpatients receiving high-risk medications. Pharmacists will place orders for specific drug monitoring labs or other variables (if not already performed) and will collaborate with primary teams if any abnormal or actionable values result. Changes to Insulin Protocol for COVID Positive Patients

An alternate Insulin Infusion Protocol (IIP) is now available for use in COVID+ and PUI patients. Key differences to the COVID IIP from the current (non-COVID) IIP allows a slightly higher blood glucose range and less frequent blood glucose determinations. The updated protocol is attached.

Occupational Medicine FAQ for Employees regarding COVID-19

Occupational Medicine and Wellness Services have created a list of Frequently Asked Questions (FAQ) for employees, covering topics such as symptoms, how to manage COVID-19 exposures, actions following a positive or negative test and documentation needed to return to work. The FAQ document is attached.

Pre-visit screening workflow for COVID-19

Pre-visit screening for COVID-19 assists in identifying and separating positive COVID patients from others in order to protect staff and patients. Additional screening questions have been added to the pre visit screening assessment. The tips and tricks are attached.

- Please do not wear makeup such as foundation or lipstick as they soil the facemasks and respirators making them ineligible for reprocessing. Makeup is the #1 cause of being unable to reprocess.





Below you will find an overview of the total number of inpatients who are positive or under investigation with COVID-19 and updated testing results from across the Health System. These numbers are from our JDAT team.






