Message from the Chief Clinical Officer

Dear Colleagues,

In the last week, we have experienced a large increase in COVID-19 admissions across the System and a sharp increase in COVID-19 test positivity rates across our laboratories. We are clearly in a second surge of COVID-19 infections.

We have declared a Code D across the System to facilitate the rapid operational changes that may be required. Some key operational details follow.

- We are well prepared from a PPE and supply chain perspective to support and protect our clinical front lines.
- Our testing enterprise is working to increase specimen collection capacity, and continues to increase our lab capacity; we anticipate a significant testing capacity bump at the beginning of December when pooled testing and a new testing platform come on line.
- Our hospitals are working to increase the number of COVID-19 designated units and reduce the close quarters of patients in the EDs
- We are working on patient-facing materials to encourage the use of alternative settings, including PCPs, specialists, urgent care centers, etc., for non-emergent clinical evaluation.

The increased community prevalence of COVID-19 requires a change to how we manage infection control within our facilities.

- Our Infection Prevention team is transitioning from a containment to a mitigation strategy. This transition means contact tracing will be more limited, and only symptomatic or COVID-19-positive healthcare workers will need to quarantine.
- Those returning after risk travel or have symptoms concerning for COVID-19 should self-schedule testing at https://ocucovidtesting.ynhhs.org. No call to the Call Center is needed.
- Asymptomatic individuals with potential COVID-19 exposures should discuss with their leaders and may use Occupational Health as a resource.
- In alignment with orders the State of Connecticut, we are reducing the number of individuals who are permitted to be present for in-person meetings.


Please ensure Patient/Family Communication iPads are ready for use and place InTouch Cart in assigned room, plug into power source and power on ASAP.
